The "Excursion" involves risks, dangers and hazards resulting from many different circumstances, including: collisions with man-made and natural objects; changing weather and sea conditions; equipment faults and/or failure; negligence on the part of any person or party and other circumstances not referred to herein but inherent in the hazards which may be encountered in subject environments. I willingly accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting therefrom as my own risk. I understand that the excursion is not recommended for people with spinal, back, neck or hip problems, in frail health or for anyone with health conditions that may be aggravated by the changing sea conditions.

I have been informed that the use of a full face mask is strongly discouraged and carries additional risks of dizziness, unconsciousness and even death. And these masks are not suitable for this tour.

- 4. Follow local rules of the national marine park.
- 5. Understand that the failure to respect Dominica's fragile reef systems by deliberately touching the reef could result in the premature termination of my snorkeling tour
- 6. Acknowledge having examined the equipment and have satisfied myself that it is in good order and working condition before I go snorkeling. I hereby accept the equipment in the condition as is. PH Whale Watch Dominica accepts no responsibility for any defect in the equipment and does not warrant that it is suitable for any particular purpose. I agree that the use of said equipment is at my own risk. I shall return the same in good order and working condition and shall be financially liable for any deviations therefrom.
